

2.2 Management Volume Cross-Reference Tables

L.34.2 The offeror shall prepare its Management Volume to address all applicable requirements specified in this RFP and reflected in the cross reference tables in the Networkx Hosting Center. {Amendment 5, L.34.2}

L.34.2.2 The RFP requirements for the Management Volume are summarized in conformance and compliance cross reference tables as presented in the Networkx Hosting Center. The cross reference tables are provided to assist the offeror in preparing its proposal. In the event the tables are in conflict with the above referenced RFP requirements, the RFP requirements shall take precedence.

(a) Conformance Requirements Table. The offeror shall submit its response to Management Volume conformance requirements to the Networkx Hosting Center. The offeror's response shall provide a management Volume reference for any narrative language that is required to satisfy a conformance requirement, including any exceptions or deviations that are taken to a requirement.

(b) Management Requirements Table. The offeror shall submit its response to all management requirements to the Networkx Hosting Center. If the offeror agrees to comply with a specific stipulated requirements in its entirety, no additional language pertaining to that requirement shall be provided.

If the offeror proposes exceptions or deviations to any stipulated requirement, the rationale shall be stated in the Management Volume and proposal references shall be provided in the cross reference table.

For every narrative requirement, the offeror shall provide a Management Volume reference in the cross reference table that identifies where the narrative response can be found.

If the offeror proposes exceptions or deviations to any narrative requirement, the rationale shall be stated in the Management Volume and proposal references shall be provided in the cross reference table. {Amendment 5, L.34.2.2}
